**Data storage**

Personal data is stored by the 'Data controller' for current members only. If at any time you wish to leave the society, your Data will be deleted at the end of the programme year unless you request to be kept for use on the mailing/notification list. Data will be stored electronically of which, it will only be used for membership management and renewals or to inform members about Society activities, including to the distribution of our Society literature, to contact members individually and, if required, for Society purposes. This data may also be shared with committee members as required to carry out their functions.

**Members rights to amend or withdraw data**

You can change or request the deletion of your data or withdraw your consent to any further processing of your data at any time by contacting the 'Data controller' in writing. Please note that all use by TASS of your personal data will cease once you have withdrawn consent, other than where this is required by law, but this will not affect any personal data already processed prior to this point.
